Group work summary - Assistive Technology

Group 2:

Consider needs of individual and find technology to suit their requirements

One suggestion would be for one person from the institute to research the market for assistive technology

On the other hand, it may not be necessary to use hi-technology a starting point to consider might be: what does the student need, it may be something very simple, review their individual plan and consider what may meet their need.

Avoid putting the main emphasis on technology; we need to consider the holistic approach to the person's needs.

Group 4

Technology needs to meet the individual requirements of the person and assessment needs to be holistic.

Creative and imaginative approach to meeting technology

Careful thought about appropriate resources, software, equipment to meet the need, (it is not always the most expensive piece of equipment that is necessary.)

Professionals need to assess the piece of equipment and the extent of the opportunities that it offers to meet the access needs of the person.

Bank of technology – library system
